Course Description

In this course, we consider the historical, philosophical, and socio-cultural foundations of higher education. Moving from mediaeval times to the present, various disciplinary and comparative perspectives of higher education are examined. The historical, social, political and cultural forces that shaped Canadian higher education development are of particular interest. This course also entails a critical examination of current social, cultural, political, and philosophical dynamics that serve to both maintain and change the higher education system.

In this course, we will 1) introduce the key institutions of higher education as they have developed in Europe and North America, and 2) examine how higher education is investigated from various disciplinary perspectives. Our seminars will explore institutional growth and change, the politics of inclusion and exclusion, and the conflicts and continuities that have shaped the development of higher education.

Course Evaluation

Students are required to attend all seminars. It is also expected that students will have completed the relevant readings for each class.

Evaluation of this course will be based on one critical book review, one critical analysis, one examination, and class participation. **Assignments must be submitted on or before the due dates.**

1. Critical Book Reviews

Students are required to prepare two critical book/report reviews. Each review, which will not exceed 1500 words, will 1) succinctly summarize each chapter, and 2) critically discuss the merits of the book for the study of higher education in relation to the course readings. Each book review is worth **25%** of the final grade. The first review is due at 4:30 p.m. on **February 26, 2015**, and the second is due at 4:30 p.m. on **March 19, 2015**.

2. Paper

Students will write a paper, approximately 15-20 pages in length on a topic that is relevant to EDST 521. On **February 5, 2015**, each student will submit an 1-2 page outline of the paper. The outline, worth **10%** of the final grade, should include a description of the central focus of the paper and the major headings for each section. Within one week, I will meet with each student to discuss the outline. On **April 9, 2015** the final paper, worth **40%** of the course grade, is due.

3. Participation

The grade for participation will be based on three criteria: 1) attendance, 2) evidence of having read the relevant readings, and 3) meaningful contributions in class. A total of **10%** of the grade may be earned through participation. A self-evaluation of participation will be completed by all students at the end of the course.

Each student will be expected to arrive at class prepared to set the tone of the discussion by posing questions about the week's readings. Students will not be assigned to specific weeks; rather, you are invited to participate on a voluntary basis.
